## Stud Service Agreement

Under the terms of this agreement, the undersigned parties agree to the following conditions in regard to the breeding of the Golden Retriever identified below:

1. The fee for this service will be \$1,000.00
  - a. A fee of \$275.00 will be due when the bitch arrives for breeding or prior to semen collection and shipment. This is non-refundable and is non-applicable to any future breedings.
  - b. The AKC Litter Registration Application will not be signed until the stud fee is paid in full.
  - c. A fee of \$145.00 per puppy applied to the first five puppies born. No fee for each additional puppy over the initial \$1,000.00.
  - d. Progesterone testing will be done at stud dog owners discretion. The cost of these tests are the responsibility of the bitch owner and said bitch will not be released until charges are paid in full.
  
2. Prior to breeding, the Stud dog owner will be provided bitch's:
  - a. 3 generation pedigree
  - b. Copies of OFA certificate for hips/elbows
  - c. eye report conducted by a member of the ACVO within 12 months prior to the date of breeding and a copy of the current CERF.
  - d. heart report performed by a member of the ACVIM or a copy of OFA cardiac certificate.
  - e. photograph of bitch in for breeding, including a frontal head shot.

- f. A negative current (within 30 days of being serviced) brucellosis report.
- g. A vaginal culture shall be taken within the first few days of coming into season and reports sent to stud dog owner. Non-treatment for overgrowth of bacteria in vaginal tract of bitch may cause this contract to be null and void.

- 3. A safe, comfortable and pleasant environment will be provided for the bitch while she is in care of stud dog owner. It is the bitch owners responsibility to provide detailed information on care of bitch including an unusual behaviors which might cause physical or emotional distress (i.e. eating of bedding material, rock eating, escape artist, bloat).

Should the bitch become ill, the bitch owner authorizes any and all emergency care. Prior to any treatment the stud dog owner will make every attempt to contact the bitch owner. If the bitch owner cannot be reached during an emergency, bitch owner authorizes treatment and will be responsible for all charages.

- 4. Should it be necessary to keep the bitch longer than 10 days a boarding fee of \$7.50 per day will be charged.
- 5. The owner of the stud dog shall sign the litter registration application upon proper evidence of birth of the litter, the puppies being no younger than 7 days and no older than 8 weeks.
- 6. The bitch owner agrees not to sell any puppies resulting from this breeding outside the U.S.A. or Canada without written permission from stud dog owner.
- 7. All expenses related to collection, handling and shipping of fresh chilled semen will Be the responsibility of the bitch owner.
- 8. No puppies as a result of this breeding may be sold to pet dealers, brokers or anyone negotiating transfer of puppy to overseas homes. The bitch will not be sold in whelp. The owner of the bitch agrees to sell all pet puppies on a spay/neuter contract. The name, address and phone number of the stud dog owner will be provided to all puppy owners.
